Hugh Morris, Principal Consultant, leads the Morris Risk Services (MRS) team, a founding partner of The Kennington Alliance. Hugh holds a Master of Administration degree and a Graduate Diploma in Public Administration. The particular focus of MRS in recent years has been upon the adoption of a quality systems based approach to organisational and operational liability risk exposures and issues in a changing environment with use of Australian Standards. These have included AS 4360:1995 (Risk Management), AS 3806:1998 (Compliance), AS 4269:1995 (Complaints Handling) and AS 4804:1997 (OH&S Compliance) as well as other Industry specific Standards as the AS 4292 (Railway Safety) series.

Since 1994 the Principals of MRS have developed and successfully implemented a quality systems based process for use in the systematic identification, assessment and management of corporate risk exposures. The use of this process has evolved to have a greater focus upon the management of corporate legal, professional and compliance related liability exposures. This has included the development of appropriate and effective risk management tools to address due diligence and governance related issues.
